I agree that you shall be the exclusive owner of all copyright and other rights in and to the Programming and Performance and will be able to use them forever and throughout the world, and to license others to use them, in any manner you wish and in any and all media now known or hereafter discovered or developed.

I further irrevocably agree that you may use and license others to use the Performance or excerpts therefrom, and my name, voice, likeness and any biographical facts which may have been provided to you, in the Programming, and in any related or derivative versions and/or uses of the Programming (including, without limitation, any serialization(s), translation(s) and/or adaptation(s) thereof), and in the advertising, marketing and promotion of the Programming, Nickelodeon, MTV Networks and/or Company, in all mediums and/or media, including but not limited to merchandising of the Programming, its related products, Nickelodeon, MTV Networks and/or Company. I confirm that, to the best of my knowledge, any statements made by me during the Performance will be true and will not violate or infringe upon any third party's rights.

I hereby agree not to sue, and I hereby irrevocably and unconditionally release, waive and forever discharge, Company, its past, present and future parents, subsidiaries (whether or not wholly-owned), affiliates, divisions, agents, representatives, employees, successors and assigns, jointly and individually (hereinafter collectively referred to as "Releasees"), from any and all manner of liabilities, claims and demands of any kind or nature whatsoever, in law or equity, whether known or unknown, which I (or my assigns, agents and/or representatives) ever had, now have, or in the future may have against the Releasees, including but not limited to claims arising out of or related to the uses described herein, the Event, the Programming, the Performance, and/or my decision to perform the Event. I further agree that I shall be liable for any attorneys' fees and costs incurred by Company in connection with any claim or lawsuit brought in violation of this Release. In no event shall I have the right to enjoin the development, production or distribution or exploitation of the Programming. Company may transfer and assign this Release or all or any of its rights or privileges hereunder to any entity or individual without restriction. This Release shall be binding on all of my successors-in-interest and heirs. This Release sets forth the entire agreement between us with respect to the subject matter hereof and may not be altered or amended except in writing signed by both parties. This Release shall be governed by the laws of the State of New York. The parties hereto agree to submit to jurisdiction in the State of New York.
